The column "Organism" displays the host which originally harboured the studied microbiota (can be different than the experimental animal in cases of gnotobiotic models). "Microbiota members" includes the major taxa which differed between the interventional group to control or before and after treatment, where "Up:" indicates taxa which were relatively more abundant or that increased following intervention, and "Down:" indicates taxa which were less abundant or that decreased following intervention. The column "Phenotype" usually refers to observed clinical features. "Causative / associative" indicates the nature of the link found between the diet and the microbiota to the phenotype (if an inverse correlation is found or if the phenotype is attenuated by the diet and the microbiota, the word "inverse" appears in brackets). "Methods of confirmation" are specified in case of a causative interactions.
